Be it enacted by the Senate and House of Representa tives of the United States of America in Congress assembled,
 SECTION 1. RATE OF MILITARY BASIC PAY FOR THE SEN IOR ENLISTED ADVISORS TO THE COM MANDERS OF THE COMBATANT COMMANDS.
 (a) IN GENERAL.—Effective for months beginning on
 or after January 1, 2017, the rate of monthly basic pay

for the Senior Enlisted Advisors to the commanders of the
 combatant commands shall be equivalent to the rate of
 monthly basic pay for the Senior Enlisted Advisor to the
 Chairman of the Joint Chiefs of Staff.

5 (b) CONFORMING AMENDMENT.—Effective with respect to months beginning on or after January 1, 2017, 6 7 footnote 2 accompanying the enlisted members pay table 8 in section 601(c) of the John Warner National Defense 9 Authorization Act for Fiscal Year 2007 (Public Law 109– 10 364; 120 Stat. 2245; 37 U.S.C. 1009 note) is amended by striking "or Senior Enlisted Advisor to the Chairman 11 of the Joint Chiefs of Staff" and inserting "Senior En-12 13 listed Advisor to the Chairman of the Joint Chiefs of Staff, or Senior Enlisted Advisor to the commander of a 14 15 combatant command".

16SEC. 2. REPORT ON INCLUSION OF ADDITIONAL SENIOR17ENLISTED MEMBERS AMONG ENLISTED MEM-18BERS ENTITLED TO ELEVATED RATE OF MILI-19TARY BASIC PAY.

(a) REPORT REQUIRED.—Not later than 180 days
after the date of the enactment of this Act, the Secretary
of Defense shall submit to Congress a report setting forth
an assessment of the advisability of including additional
senior enlisted members of the Armed Forces among the
most senior enlisted members of the Armed Forces who

are entitled to an elevated rate of military basic pay by 1 2 reason of footnote 2 accompanying the enlisted members 3 pay table in section 601(c) of the John Warner National 4 Defense Authorization Act for Fiscal Year 2007 (Public Law 109–364; 120 Stat. 2245; 37 U.S.C. 1009 note) and 5 related guidance (including the material commonly ap-6 7 pearing as footnote 4 accompanying the annual military 8 pay tables published by the Defense Finance and Account-9 ing Service).

10 (b) MEMBERS OR CATEGORIES OF MEMBERS.—If the 11 Secretary determines that the inclusion of any additional 12 enlisted members or categories of enlisted members as de-13 scribed in subsection (a) is advisable, the report under 14 that subsection shall specify such additional members or 15 categories of members.

16 SEC. 3. MODIFICATION OF AUTHORITY OF PRESIDENT TO
17 DETERMINE ALTERNATIVE PAY ADJUSTMENT
18 IN ANNUAL BASIC PAY OF MEMBERS OF THE
19 UNIFORMED SERVICES.
20 (a) MODIFICATION.—Section 1009(e) of title 37,

21 United States Code, is amended—

(1) in paragraph (1), by striking "or serious
economic conditions affecting the general welfare";

3 (b) EFFECTIVE DATE.—The amendments made by
4 subsection (a) shall take effect on the date of the enact5 ment of this Act, and—

6 (1) if the date of the enactment of this Act oc7 curs before September 1 of a year, shall apply with
8 respect to plans for alternative pay adjustments for
9 any year beginning after such year; and

(2) if the date of the enactment of this Act occurs after August 31 of a year, shall apply with respect to plans for alternative pay adjustments for
any year beginning after the year following such
year.
